### ABOUT THE PARENT AND FAMILY ENGAGEMENT STATEMENT

Our goal as the Title I Department within the Atlanta Public Schools (APS) system is to ensure parents are full partners in their child's education. We understand that when families, schools, and communities work together in supporting learning, children tend to do better in school.

### WHAT IS TITLE I?

[Title I](#) is a federal program that provides funding to local school districts to help ensure that all children in district Title I schools meet state's high academic standards. Title I, Part A provides for substantive parent and family engagement at every level serving students in grades K-12. Section 1116 of Every Student Succeeds Act ([ESSA](#)) contains the primary Title I, Part A requirement for schools and school systems to involve parents and family members in their children's education.

## WHAT IS PARENT AND FAMILY ENGAGEMENT?

Parent and Family Engagement means the participation of parents and family members in regular, two-way, and meaningful communication involving student academic learning, and other school activities. It ensures:

- (A) that parents play an integral role in assisting their child's learning.
- (B) that parents are encouraged to be actively involved in the their child's education.
- (C) that parents are full partners in their child's education and are included, as appropriate, in decision-making and on advisory committees to assist in the education of their child.
- (D) the carrying out of other activities, such as those described in Section 1116 of [ESSA](#).



## JOINTLY DEVELOPED

Atlanta Public Schools District (APS) solicits feedback and input of all parents and families whose children are being served in Title I schools. The Title I Department has a Parent and Family Engagement link on [www.atlanta.k12.ga.us](http://www.atlanta.k12.ga.us) district webpage under the Department Section. Parents and families will find a survey link allowing them to provide feedback and input on this statement. This policy is developed jointly with the input of APS and Title I stakeholders. Parents and families will be invited attend the District Parent Feedback Meeting in the Spring of 2019.

## STRENGTHENING OUR SCHOOLS

The Title I Department in partnership with the district's Family Engagement Department provides a strategy of operation, technical support and professional development to all Title I schools on effective parent and family engagement practices and Title I requirements and regulations. Schools will be given the tools and resources to provide school level training to build the capacity of their staff, parents, and families. In addition to the district level training opportunities, schools are encouraged to participate in the Parent Engagement Webinar series offered by the Georgia Department of Education. The Title I Department will also conduct regular school visits to monitor program implementation and to provide on-site technical support designed to enhance parent and family engagement at schools.

## RESERVATION OF FUNDS

APS reserves greater than the required 1 percent from the total amount of the Title I funds allocated for the 2018-2019 school year to carry out the parent and family engagement requirements listed in this statement and as described in Section 1116 of the ESSA. APS asks parents for feedback on using the 1 percent for family engagement activities by including a question in the parent survey for this statement. APS distributes funds to schools based on student enrollment. Schools that have 400 students or less receive \$6,000. Schools that have a student population of 401 to 699 receive \$11,000, and schools with student population at 700 and above receive \$15,000. APS will give clear guidance and communication to assist each Title I school in developing and adequately utilizing Title I funds appropriately to support needs assessments and parent engagement programs.



## BUILDING SCHOOL AND PARENT CAPACITY

APS will build the schools', parent and families' capacity for strong family engagement, in order to ensure effective involvement of parents and family members. The goal is to support partnerships among the Title I schools, parents, and the community to improve student academic achievement.

### **Build Capacity for Schools includes-**

The district will host quarterly Title I professional training for schools and principals (or designee). During the trainings, Title I Part A, Parent and Family Engagement requirements are shared in addition to strategies to increase parent and family engagement, improve school-family communication, create a welcoming environment, improve two-way communication, and build ties with parents and communities. The information shared may be redelivered to school level staff to further enhance the capacity of all staff in the school building. Training on how to effectively implement the [Academic Parent Teacher Team \(APTT\)](#) program will be supported by veteran schools and the Family Engagement staff. Teachers will receive training on proper implementation of the program. APTT is an evidence-based family engagement model that builds partnerships with parents.

Encourage schools to send a representative to the local and national professional conferences. Conferences provides an opportunity for schools to network with other districts and learn best practices in the field of parent and family engagement.



### **Build Capacity of Parents and Families includes-**

Provide parents with academic resources to support learning at home. The Title I Department will provide assistance to parents in understanding state and district academic standards, as well as, information about the Title I program and Academic Parent Teacher Teams (APTT). This information will be shared via the district's Title I Parent and website and through our social media page. Parents will also have an opportunity to learn more about the standards and obtain additional resources through the school parent liaison and /or parent resource center.

For participating schools, parents will participate in the APTT program. APTT is an evidence-based family engagement model that builds partnerships with parents and set academic goals for students that can be addressed and achieved through at-home learning activities and strategies. The APTT program is currently being implemented at 11 of our Title I schools. As a note, there are two other options available in the Family Engagement Choice programs – Removing Barriers and School Designed that increase parent, student, and school dialogue on academic success and instructional supports.

Atlanta Public School will coordinate and collaborate with federal and state funded preschool programs within the district and locally, inviting faculty to participate in meetings focused on parent and family engagement. In the spring, elementary schools will host Kindergarten Round-Up engaging parents/families in touring schools and sharing information with parents and families for a smooth transition into kindergarten.

Provide parents with information in an understandable and uniform format, and to the extent practical, in a language that parents can understand.

## OPPORTUNITIES FOR MEANINGFUL PARENT AND FAMILY CONSULTATION

Parents, families, and community stakeholder input is essential to the Title I Part A, Parent and Family Engagement program. All parents and families of students eligible to receive Title I services are invited to participate in the following opportunities to share their ideas and suggestions to help the district, schools, and students reach our student achievement goals.
